February 2014 Management Board (MB) Conference Call

Annapolis, MD February 13, 2014

The MB held a two-hour conference call on February 13th in lieu of their monthly in-person meeting due to inclement weather. Key agenda items included: Discussion of the process for public comment review of the Chesapeake Bay Program's (CBP) New Bay Agreement, a presentation by Nita Sylvester (EPA) on supplemental wastewater indicators, a presentation by John Kuriawa (NOAA) on Coastal Zone Management in the Chesapeake Bay, and an update from STAC's Carl Hershner (VIMS) on STAC recommendations for New Bay Agreement goal and outcome statements.

MB members were largely supportive of STAC's recommendations, but expressed concern that it is too late in the Agreement process to make these changes and still finalize the document in time for a mid-year signing at the 2014 Executive Council meeting. STAC Chair Kirk Havens (VIMS) said he, Hershner, and CBP Director Nick DiPasquale (EPA-Chesapeake Bay Program Office) will talk offline to decide how STAC and the Chesapeake Bay Program Office (CBPO) can discuss this process at the March 2014 STAC Quarterly Meeting. MB and STAC members agreed that these recommendations should be treated differently from other STAC submittals in that STAC will not require a 60 day response, and that these recommendations can be considered and potentially incorporated more quickly if the CBPO Issues Resolution Committee (IRC) is used to move these issues to the Principals' Staff Committee (PSC) for approval.

Dr. Cynthia Jones (Old Dominion University) Joins STAC

STAR Updates

The Scientific, Technical Assessment, and Reporting (STAR) Team's monthly meeting was held on January 23, 2014. All STAR workgroups presented their 2014 work plans at the meeting. These work plans can be reviewed on the STAR meeting website: http://www.chesapeakebay.net/S=0/calendar/event/21277/.

STAR's Building and Sustaining Integrated Networks (BASIN) process is ongoing. Phase II of BASIN is in progress and includes the review, through panel discussions, of how other long-term monitoring programs conduct and fund their network activities.

The First BASIN International Long-term Monitoring Programs Panel was held on December 6, 2013. This panel included case studies from the U.S. Geological Survey (USGS) Great Lakes Monitoring Program and the Puget Sound Partnership. The Second BASIN International Long-term Monitoring Panel was held on Friday, January 10, 2014. This panel included case studies from the Mid-Atlantic Regional Association Coastal Ocean Observing System (MARACOOS), the Upper Mississippi River Basin Association (UMRBA), and the Great Barrier Reef of Australia.

STAC and STAR will continue to collaborate on BASIN Phase II and Phase III work in 2014. In Phase II, STAR will focus on Chesapeake Bay tidal and non-tidal water quality monitoring programs, and in Phase III, STAC will take a detailed look at overall monitoring needs associated with tracking progress of the Chesapeake Bay Program's New Bay Agreement goals and outcomes. The Modeling Workgroup and Modeling Team continue to work on Midpoint Assessment Priorities.

STAR also held a seminar on February 21st titled, "STAR Seminar: Human Impacts on the Nitrogen Cycle."

GIT Updates

*The following updates are provided by the Chesapeake Bay Program. Some GITs do not have recent updates to provide at this time.

Sustainable Fisheries Goal Implementation Team (GIT 1)

GIT 1 held a meeting January 13, 2014. The agenda covered a wide range of topics, including a request for a Chesapeake Bay Stock Assessment Committee (CBSAC) Review of winter dredge fishery triggers in Virginia. The CBSAC will review the management trigger options proposed by the Virginia Marine Resources Commission (VMRC) by May 2014.

Other agenda items included: Debrief of the December 2013 Full GIT 1 meeting; updated GIT work plans for 2014; updates from the Invasive Catfish Task Force process; and discussion of 2014 meeting dates and science presentation topics. Water Quality Goal Implementation Team (GIT 3)

GIT 3 held a conference call on February 10th. Agenda topics included: A review of draft GIT 3 governance protocol; a presentation by Urban Stormwater Workgroup Coordinator Tom Schueler on the workgroup's proposal to credit homeowner Best Management Practices (BMPs) (currently pending Watershed Technical Workgroup and GIT 3 approval); an update on the Midpoint Assessment Schedule and path forward; presentation of GIT 3 workgroup priorities; and Phase 6.0/Modeling Quarterly Review updates.

Maintain Healthy Watersheds Goal Implementation Team (GIT 4)

At GIT4's face-to-face meeting on December 19th, GIT4 members affirmed that the following strategies are important for GIT4 moving forward:

- Develop a method to track and report watershed health and protection.
- Engage with local governments, land trusts, and other local stakeholders.
- Develop outreach and communications tools.
- Improve policy and program efficiency.

Renee Thompson, a former CRC Fellow at the CBP, joined the leadership of GIT 4 as Coordinator in January 2014. Renee is a geographer with USGS at the CBPO. She holds a B.S. degree from University of Hawaii at Manoa in Global Environmental Science, and a Master's degree at the University of Maryland in Urban Studies and Planning with a focus on land use and the environment.

Thompson and GIT 4 Staff Tuana Phillips (CRC) are in the process of forming and convening a Local Engagement Workgroup and a Tracking *Ad Hoc* Group to address GIT 4's strategic priorities. The two groups will meet for the first time in March or April, 2014.

GIT 4 is currently preparing for a meeting in March 2014. This meeting will include two case study presentations – one related to local engagement, and the other to tracking healthy watersheds. Also at this meeting, GIT 4 members will collectively reflect on management strategies and workgroup and *ad hoc* group progress to date.

Fostering Stewardship Goal Implementation Team (GIT 5)

GIT 5's upcoming focus areas include protecting 2 million acres and measuring coverage with Landscope to aggregate land conservation, land prioritization, and recreation data, increasing public access sites by 300 locations by 2025 through implementation of the Public Access Strategy which sets the baseline for public access sites, potential locations, demand for these sites, and challenges to developing an increased amount of sites.

GIT 5 is also examining Environmental Literacy. The current metric for measuring environmental literacy is the MWEE (Meaningful Watershed Educational Experience) but GIT 5 is trying to develop a new metric/indicator for the Environmental Literacy goal. GIT 5 is also considering development of a behavior metric index to measure successes in public behavior changes, but could not reach consensus to propose the metric for consideration within the new Bay agreement.

Partnering and Leadership Goal Implementation Team (GIT 6)

GIT 6 cancelled its January 7th meeting to wait for additional guidance from the MB and PSC on program governance. The PSC held a call on January 16th to provide GIT 6 with a charge and timeline for re-evaluating the CBP governance document and the definition of a full CBP "partner."

GIT 6 also held a call on February 4th. Agenda items included: Discussion of ChesapeakeStat, discussion of the general public comment process and public comment meetings schedule (the first will occur on March 13th) for the CBP New Bay Agreement, discussion of governance, and an update from the Evaluator Function workgroup.

GIT 6 will track all comments during the public comment period and discuss/incorporate new suggestions to the new Bay agreement, along with the help from the CBP Editorial Board and IRC.
